Community Meeting with DEC representatives Unitarian Universalist Church September 28, 7:00 pm

Selinda Brandon, from the DEC, presented an informational meeting to the community. Mike Clark and Regina Willis also attended the meeting as representatives from DEC.

- Approximately 40 community members were in attendance.
- Tone was interested, supportive, and respectful.
- Questions from the participants increased understanding of the current deer population problem and techniques for mitigation.

Mitigation Issues suggested by the DEC:

- Feeding deer is not only illegal, it is harmful to the deer. It was recommended that deer feeding be reported to the DEC office. They can issue a warning and if needed follow up with citations.

Selinda discussed a variety of mitigation procedures that could be implemented:

- Wooded areas behind SUNY, Hartwick College, and city owned property could be considered for special deer hunting permits from the DEC for the purpose of deer management. This would increase the taking of does. (Removing a buck, removes one deer from the herd. Removing a doe has the potential of removing three deer.). Private landowners who live in wooded areas outside the city limits may also apply for these special permits and may allow others to hunt on their land. The landowner can require who can hunt, when they can hunt, and where exactly on their land hunting can occur.
